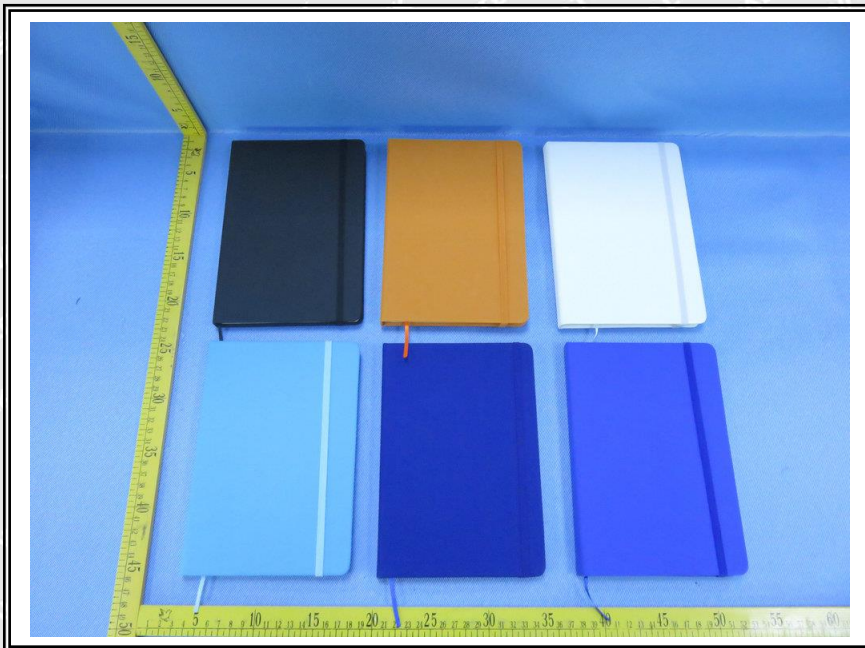

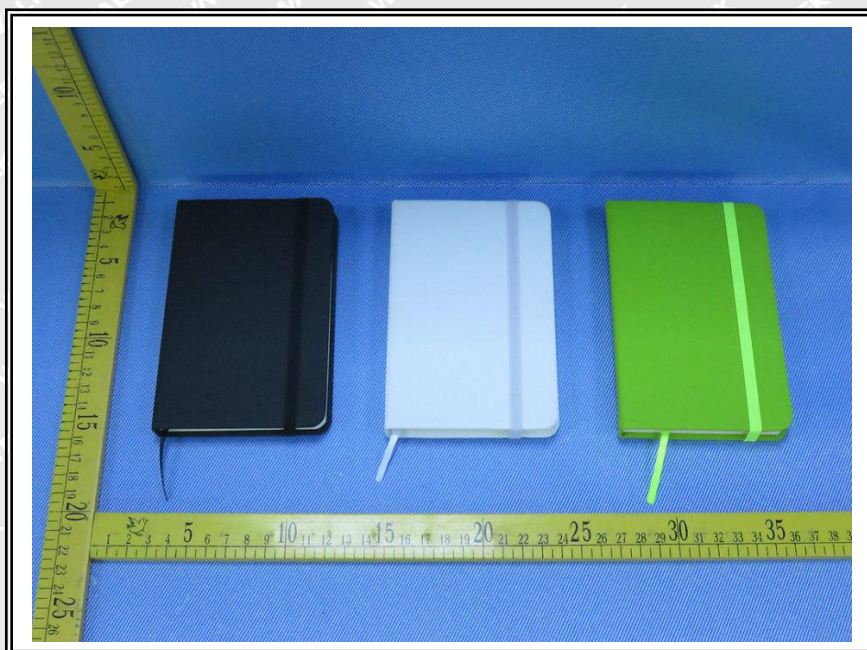
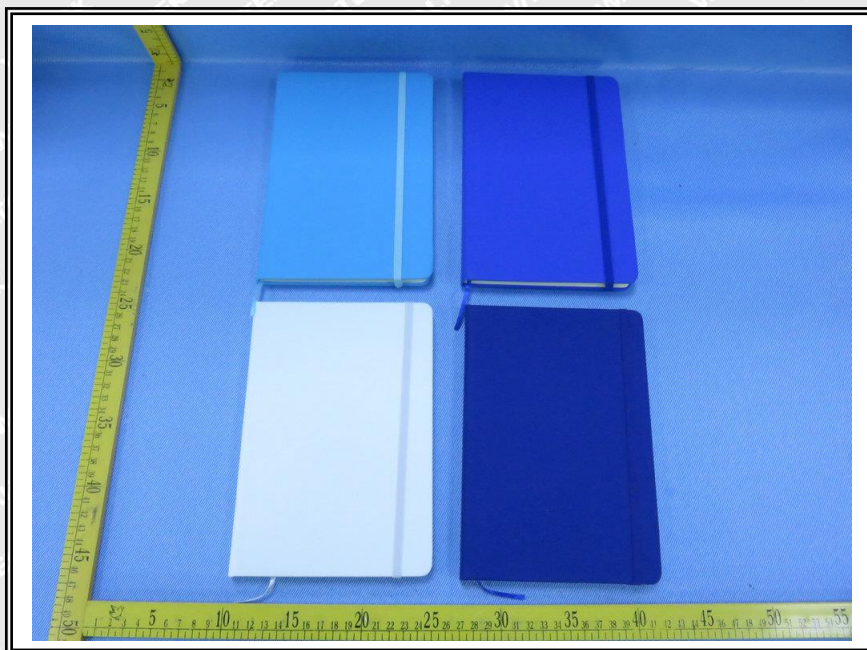

- No.9: White paper with black printing

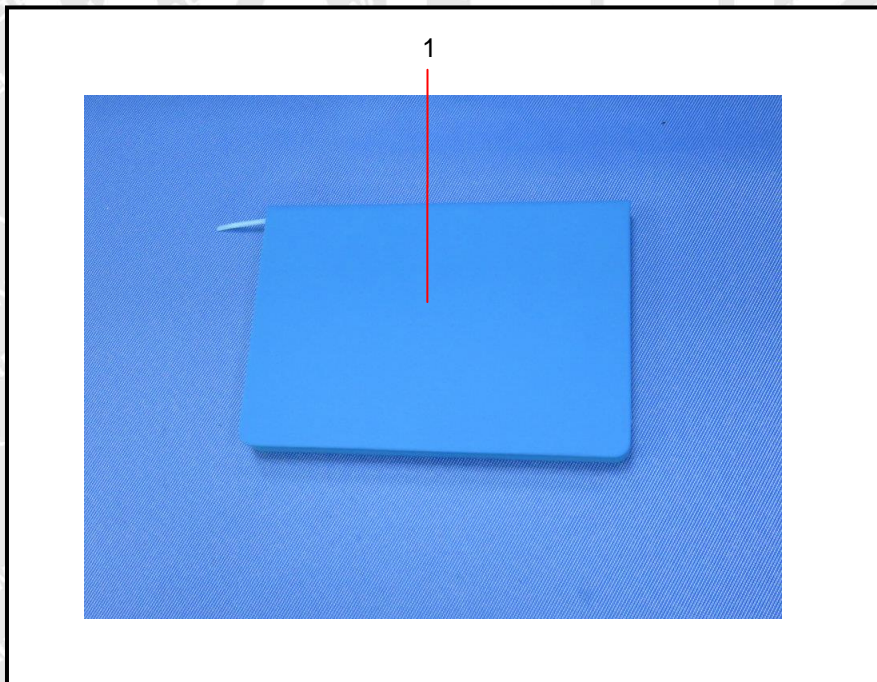
